PROCEDURE FOR THE ENTRY AND EXIT OF SPORTS TEAMS, MANAGERS,

REFEREES AND STAFF INVOLVED

1. ENTRY PERMIT FOR FOREIGN PEOPLE

1.1. Foreigners who are part of the sports teams of each country as well as the directors,

referees

and personnel involved who intend to enter the Argentine Republic in order to take part in the

"Sports Event" must necessarily process the corresponding entry permit, through of each club,

association, company or body that brings them together.

1.2. Foreigners included in the previous section will be granted an authorized period of stay of

ONE (1) month (except the existence of a pre-existing agreement with the requesting country),

counting from the time of entry, the immigration control authority previously owed, Verify that

they are included in the list sent no less than FIVE (5) days in advance by each club, association,

company or body that brings them together, which will be duly loaded into the computer system

of the National Directorate of Migration.

1.3. The aforementioned lists must be sent to the National Directorate of Migration within a

period of no less than FIVE (5) days prior to the date of the trip to the Argentine Republic and

the following information must be detailed:

• NAME AND SURNAME

DATE OF BIRTH

• TYPE OF DOCUMENT: IDENTITY CARD / PASSPORT / MEAT / OTHERS

• PASSPORT NUMBER

NATIONALITY

ADDRESS

1.4. Likewise, the scan of each of the passports that make up said list must be attached so that

the immigration authority can validate the data submitted.

1.5. Once the entry permits have been issued by the National Directorate of Migration, they

will

be exempted from the consular visas of each country.

- 2. PROCEDURE FOR THE ENTRY OF PLAYERS, MANAGERS, REFEREES AND STAFF INVOLVED
- 2.1. The sports teams, managers, referees and personnel involved must, in advance TWENTY-FOUR (24) hours before starting the trip, complete the Joint Affidavit. (Ministerio de Salud Dirección Nacional de Migraciones) desde el portal de web de la Dirección Nacional de Migraciones.

- 2.2. For entry, they must be accompanied by their identification documents and the corresponding immigration entry permit, except for the existence of a pre-existing agreement with the requesting country.
- 2.3. Pursuant to MERCOSUR Decision No. 46/15, the Documents may be:
- PASSPORT
- IDENTITY CARDS
- DNI IN CASE OF BEING RESIDENTS IN THE ARGENTINE REPUBLIC
- 2.4 In case of being a holder of some type of residence in the country, you must, together, present it with the identification documentation to the immigration control agent at the entry point or step.
- 2.5 In all cases, they must be attentive to the requirements that the Immigration staff request or indicate in the positions or entry steps.
- 3. PROCEDURE FOR THE EXIT OF PLAYERS, OFFICERS, REFEREES AND STAFF INVOLVED THAT THEY ARE ARGENTINE NATIONALS AND / OR RESIDENTS IN THE COUNTRY
- 3.1 The sports teams, managers, referees and personnel involved that contain among their Argentine national members and / or residents in the country, must, with an advance of TWENTY-FOUR (24) hours before starting the trip, complete the Joint Affidavit (Ministry of Health National Directorate of Migrations) from the web portal of the Directorate National of Migrations.
- 3.2. For the discharge they must be accompanied by their identification documents established in MERCOSUR Decision No. 46/15, which may be:
- PASSPORT
- IDENTITY CARDS

- DNI IN CASE OF BEING RESIDENTS IN THE ARGENTINE REPUBLIC
- 3.3. In the case of residents in the country, all identification documents must be accompanied by proof of residence or permanence in term.
- 3.4. Those people who have a precarious residence in the Argentine Republic must present it together with the valid travel document of your nationality both upon discharge and upon reentry to be intervened by the Migration Control Authority.
